Pursuant to Section 8 of NMHH Decree no. 4/2011 (X. 6.) on the rules of auction or competitive procedure for obtaining the entitlement to frequency use (hereinafter called as Ápszr.), written questions regarding the <u>Documentation</u> may be submitted by those who have registered in accordance with the conditions set out in the Documentation and the Notice.

Payment of the registration fee and/or registration does not constitute an application for the auction procedure.



INFORMATION

to assist the completion of the registration DATASHEET for the auction procedure started for the entitlements to the radio spectrum use of the 32 GHz frequency band under case number K/230//2023.

Natural person/non-natural person to be registered: the person who, or the entity that wishes to register for the auction.

Natural person making the registration: the person who fills in the datasheet.

The **non-natural person making the registration:** the entity entrusted by the person to be registered to carry out the registration.

If the natural person or non-natural person performing the registration and the natural person or non-natural person to be registered are the same, it is sufficient to fill in only the details of the natural person or non-natural person to be registered.

If the person to be registered and/or the person making the registration is not a natural person, it is also necessary to fill in the details of the natural person completing the datasheet (the person making the registration).

The Documentation is available to the public on the website of the Auctioneer and can be downloaded in electronic form free of charge; however, only registered persons and entities may submit written questions regarding the Documentation, as specified in Section 8 (1) of the Ápszr.

Registration will be open from the day of publication of the Notice, i.e. 10 February 2023, until the application deadline, i.e. 12:00 on 13 March 2023.

Cumulative conditions of registration:

- a) completion of this Datasheet,
- b) sending the completed Datasheet to any of the contact points of the Auctioneer listed below, and
- c) proof of payment of the registration fee.

If any of the conditions are not met, the registration is invalid.

Those that have duly registered in accordance with the conditions set out in this information sheet and in the Documentation shall be entered into the registration book by the Auctioneer and shall be notified of the fact of such registration. In the event of an incomplete registration or one that is inadequate for any other reasons, the Auctioneer shall inform the party initiating the registration by indicating the deficiencies.

The amount of the registration fee is HUF 100,000 + VAT, totalling HUF 127,000 (i.e. one hundred and twenty-seven thousand forints).

The registration fee must be transferred to the Auctioneer's account number 10032000-00300939-00000017 held at the Hungarian State Treasury, and the words "Regisztráció 32 GHz" (32 GHz registration) must be indicated in the payment reference field.

The Auctioneer shall also verify the crediting of the registration fee to the payment account based on its own records.

The Auctioneer shall issue an invoice regarding the registration fee duly paid, after the respective fee has been credited on the Auctioneer's account, to the name and address of the registered person, organisation and/or the person or organisation performing the registration, in line with the datasheet completed.
