

## **NMHH Decree 5/2012 (I. 24.)**

### **on the reservation and usage fees of identifiers required for electronic communications services**

By virtue of the authorisation granted under Section 206 (1) *a*) of Act CLXXXV of 2010 on Media Services and Mass Media (hereinafter: Media Act) and proceeding within my competence as set forth in Section 109 (5) of the Media Act, I hereby order as follows:

**Section 1.** The scope of the Decree extends to

- a*) electronic communications service providers,
- b*) enterprise assigned by the Government for the operation of pan-European railway digital trunked radio systems and for the provision of related services (hereinafter: service providers)

**Section 2.** (1) For identifiers reserved and assigned in accordance with the NMHH Decree on the order of identifier management for electronic communications networks, a reservation and usage fee defined herein shall be paid.

(2)<sup>1</sup> No usage fee shall apply to:

- a*) emergency call numbers stipulated in international regulations or legislation, as well as to international and national prefixes;
- b*) single identifiers or numeric blocks of equipment authorised for testing or demonstration purposes and operated for less than 6 months;
- c*) identifiers of electronic communications services temporarily restricted or suspended by the minister in charge of electronic communications in the event of a national crisis, state of emergency or natural disaster jeopardising lives or property, or for alleviating the impacts thereof, in line with the degree of restriction or suspension.

**Section 3.** (1)<sup>2</sup> For the reservation a one-time charge of HUF 22,000 per thousand numeric blocks shall be paid.

(2)<sup>3</sup> The fee payable for the reservation of identifiers shall be determined by the National Media and Infocommunications Authority (hereinafter: the Authority) by way of a resolution on the reservation permit. When such resolution is being adopted, the fees stipulated in this Decree shall be applied. The fee shall be payable within 30 days of entry into force of the resolution, upon an invoice issued by the Authority. In case of late payment, a penalty interest equivalent to the central bank base rate shall apply.

**Section 4.** (1) The annual fee payable for the use of identifiers is featured in Annex 1 to this Decree. The monthly fee equals one-twelfth of the annual fee.

(2) The Authority shall determine the fee payable for the use of identifiers in an assignment resolution. When such resolution is being adopted, no individual discounts may be applied. The usage fee set forth in paragraph (1) shall be paid on a quarterly basis in four equal instalments, within 30 days following the target period upon an invoice issued by the Authority.

(3)<sup>4</sup> The fee payable for the use of identifiers may be invoiced after the entry into force of the assignment resolution.

(4) The Authority shall issue the invoice referred to in (2) on the basis of the fees payable for the numbers registered in the central reference database and ported to and from the service provider, less any deductions as applicable. The Authority shall not adopt a separate resolution on the changes in usage fees resulting from number porting; however, mentioned changes shall be shown on the quarterly invoice, to which a summary of data from the central reference database shall be attached.

(5) For newly assigned identifiers, the usage fee shall be paid for the period starting on the first day of the month following the start date of the permit defined in the assignment resolution or, if the start date falls on the first day of the month, prorated for the given quarter as applicable. For ported numbers, the recipient service provider shall pay the usage fee for the period starting on the first day of the month following the porting, prorated for the given quarter as applicable.

(6) As regards payment of the usage fee — in case of a mid-month porting or withdrawal of the assignment —, each fraction of a month shall be considered a full month for calculating the prorated quarterly usage fee. The fee payable for a fraction of a month shall be paid by the eligible service provider that is in possession of the identifier licence at 00:00 AM on the first day of the month.

**Section 5.** (1) The reservation and usage fees shall be transferred to the Authority's account held with the Hungarian State Treasury (account no. 10032000-00287247-00000000).

(2) The fees determined on the basis of this Decree are exclusive of value added tax.

**Section 6<sup>5</sup>**

**Section 7.** This Decree shall enter into force on 1 February 2012.
